From the Museum by-Laws- ARTICLE I
BOARD OF TRUSTEES

Section 1. Trustees shall consist of individuals who show more than usual interest and/or who have made outstanding contributions to the Museum.

Section 2. It shall be the duty of the BOARD OF TRUSTEES to establish the written policies of the Museum.

Section 3. THE BOARD OF TRUSTEES shall elect officers and those officers shall also serve as the Museum Advisory Board.

Section 4. Should any member of the BOARD OF TRUSTEES be absent without sufficient cause, presented in writing or other communication to the President, for more than two successive meetings, the position shall be automatically vacant until a successor is elected at the next annual meeting.

Section 5. A Trustee, to be eligible for reelection, must keep a paid museum membership during their three year term of office and serve as a volunteer host for at least three Sundays during their three year term of office.
